Tanzhaus Zürich, Wasserwerkstrasse 129, Bühne 2 **House Rules**

1. Entering the rooms in outdoor shoes, trainers and stilettos is prohibited. Only socks or bare feet are permitted.
2. Cooking, eating, drinking and smoking in the rooms is not permitted.
3. The team kitchen area on the 4th floor at Wasserwerkstrasse 129 is reserved for in-house resident guests and artists and may only be used by tenants with explicit agreement from Tanzhaus Zürich.
4. The changing rooms on the 4th floor are reserved for in-house resident guests and artists and may only be used by tenants with explicit agreement from Tanzhaus Zürich.
5. People with disabilities may use the lift. Please contact us in advance: info@tanzhaus-zuerich.ch, +41 (0)44 350 26 10
6. The window shutters on Bühne 2 at Wasserwerkstrasse 129 may not be operated by hand. If the shutters need to be opened or closed, a Tanzhaus technician must be informed. The company or tenant is liable for any damage to the mechanism.
7. Nothing may be adjusted, connected or reprogrammed on the sound system. The manual for the sound system is located in the bottom drawer next to the sound system.
8. Any light, sound or video equipment you bring yourself must be registered in advance. Please contact us beforehand: info@tanzhaus-zuerich.ch, +41 (0)44 350 26 10
9. Nothing may be stuck to the walls, doors or dance floor.
10. The tenant must take back all items brought along (chairs, clothing, props, etc.) after use. Anything left behind will be disposed of (a fee may apply).
11. The light switches are located in the grey cabinet to the left of the stairs at the entrance to Bühne 2. For the basic lighting, the tenant turns switches 1, 2 and 3 by 90°. Otherwise, nothing in the cabinet may be adjusted.
12. Ventilation on Bühne 2 runs automatically.

13. After use, the tenant must wipe the floor once, turn off the lights, switch off the sound system and lock up (entrance door to Bühne 2, door to the Bühne 2 backstage, door to the fire escape at the backstage, and, if applicable, the entrance door to the changing room on the 4th floor).
14. The building entrance door at Wasserwerkstrasse 129 may not be wedged open with objects. It must be kept closed from the start of the event.
15. Dancing in the window frames is not permitted.
16. Both escape routes must be kept clear at all times. No curtains may be drawn in front of them, nor may they be blocked with objects of any kind.
17. The maximum capacity of people in Bühne 2 is 200.
18. Due to the risk of injury, no changing area may be set up under the grandstand.
19. The tenant agrees to treat the rooms, furniture and technical equipment with care. Damage to furniture, technical equipment or the room must be reported to the operations office immediately. Any damage incurred will be invoiced. The tenant must hold liability insurance covering any damage to the premises or infrastructure.
20. Fire of any kind is prohibited in all rooms.
